3. **Ordinance No. 2021-18** – Introduced by Council – An Ordinance authorizing the proper city official to prepare and submit an application to participate in the Ohio Department of Natural Resources, Division of Parks and Watercraft Cooperative Boating Facility Grant Program. (First Reading)
4. **Ordinance No. 2021-19** – Introduced by Council – An Ordinance authorizing the proper city official to prepare and submit an application to participate in the J.W. and M.H. Straker Foundation for funding and declaring an emergency. (Emergency or First Reading)
5. **Ordinance No. 2021-20** – Introduced by Council – An Ordinance authorizing the Mayor to enter into an agreement with Development Strategies and Solutions (DSS) for strategic planning consulting services. (First Reading)
