 - 5. ORDINANCE NO. 10-89 – INTRODUCED BY COUNCIL – PROVIDING APPROPRIATIONS FOR USE DURING THE FISCAL YEAR 2011, AND DECLARING AN EMERGENCY.
 - 6. ORDINANCE NO. 10-91 - INTRODUCED BY COUNCIL – AUTHORIZING THE PROPER CITY OFFICIAL TO TAKE ALL ACTIONS NECESSARY TO IMPLEMENT A FURLOUGH SYSTEM, AND DECLARING AN EMERGENCY.

 - 8. ORDINANCE NO. 10-93 - INTRODUCED BY COUNCIL – AMENDING ORDINANCE NO. 06-161, WHICH ESTABLISHED THE ANNUAL SALARY OF THE PUBLIC SAFETY DIRECTOR, AND ORDINANCE NO. 06-162, WHICH ESTABLISHED THE ANNUAL SALARY OF THE PUBLIC SERVICE DIRECTOR, AND DECLARING AN EMERGENCY.
 - 9. ORDINANCE NO. 10-96 - INTRODUCED BY COUNCIL – TO PROVIDE AN EFFECTIVE MEANS FOR PROTECTING THE PUBLIC WATER SYSTEM FROM CONTAMINATION DUE TO BACKFLOW OF CONTAMINANTS THROUGH THE WATER SERVICE CONNECTION INTO THE PUBLIC WATER SYSTEM. (SECOND READING)
