14. TRAFFIC ORDER 08-01 – THERE IS HEREBY ESTABLISHED A NO PARKING AT ANYTIME ZONE ON THE NORTH SIDE OF MARKET STREET BETWEEN THIRD STREET AND POTTERS ALLEY.

15. TRAFFIC ORDER 08-02 – THERE IS HEREBY ESTABLISHED A NO PARKING ANYTIME ZONE ON THE SOUTH SIDE OF MARKET STREET BETWEEN THIRD STREET AND POTTERS ALLEY.

16. TRAFFIC ORDER 08-03 – THERE IS HEREBY ESTABLISHED A NO PARKING AT ANYTIME ZONE ON THE SOUTH SIDE OF MARKET STREET BETWEEN FOURTH STREET AND COURT ALLEY.

17. TRAFFIC ORDER 08-04 – RESCIND TRAFFIC ORDER 84-32 WHICH ESTABLISHED A 15 MINUTE PARKING ZONE DIRECTLY IN FRONT OF 522 MARKET STREET (FOGG’S DRUG STORE)
