3. ORDINANCE NO. 08-112 – INTRODUCED BY COUNCIL – AN ORDINANCE APPROVING AN AGREEMENT WITH ECONOMY LINEN & TOWEL SERVICE OF ZANESVILLE, OHIO, INC. PROVIDING FOR AN AMENDMENT OF THE 2006 OHIO ENTERPRISE ZONE PROGRAM, AND MAKING DETERMINATIONS IN CONNECTION THEREWITH, AND DECLARING AN EMERGENCY.
