**ORDINANCE NO. 00-57 (Amended)  
INTRODUCED BY COUNCIL**

**AN ORDINANCE AUTHORIZING THE PROPER CITY OFFICIAL TO AUTHORIZE THE EASTSIDE COMMUNITY MINISTRY TO PREPARE AND UTILIZE VACANT CITY LOTS FOR ATTENDEE PARKING.**

**WHEREAS**, Eastside Community Ministry is completing construction of their new facility between Wayne Avenue and Stillwell Street; and

**WHEREAS**, the City owns vacant lots #13, #14, #15, and a portion of #12 in the George Row Addition along Wayne Avenue (see Attachment "A"); and

**WHEREAS**, these vacant lots serve no Municipal purpose to the City; and

**WHEREAS**, the Eastside Community Ministry is willing to prepare the lots for parking and maintain them; and

**WHEREAS**, this action would benefit the Eastside Community Ministry, its attendees, and remove the maintenance requirement by the City.

**NOW, THEREFORE, BE IT ORDAINED** by the Council of the City of Zanesville, State of Ohio, that:

**SECTION ONE:** The proper City official is hereby authorized to enter into an agreement to permit the Eastside Community Ministry to utilize Lots #12, #13, #14, and #15 in the George Row Addition for parking by Eastside Community Ministry attendees.

**SECTION TWO:** The City of Zanesville shall retain ownership of the property and reserve all rights for future use.

**SECTION THREE:** This Ordinance shall take effect and be in force from and after the earliest period allowed by law.
