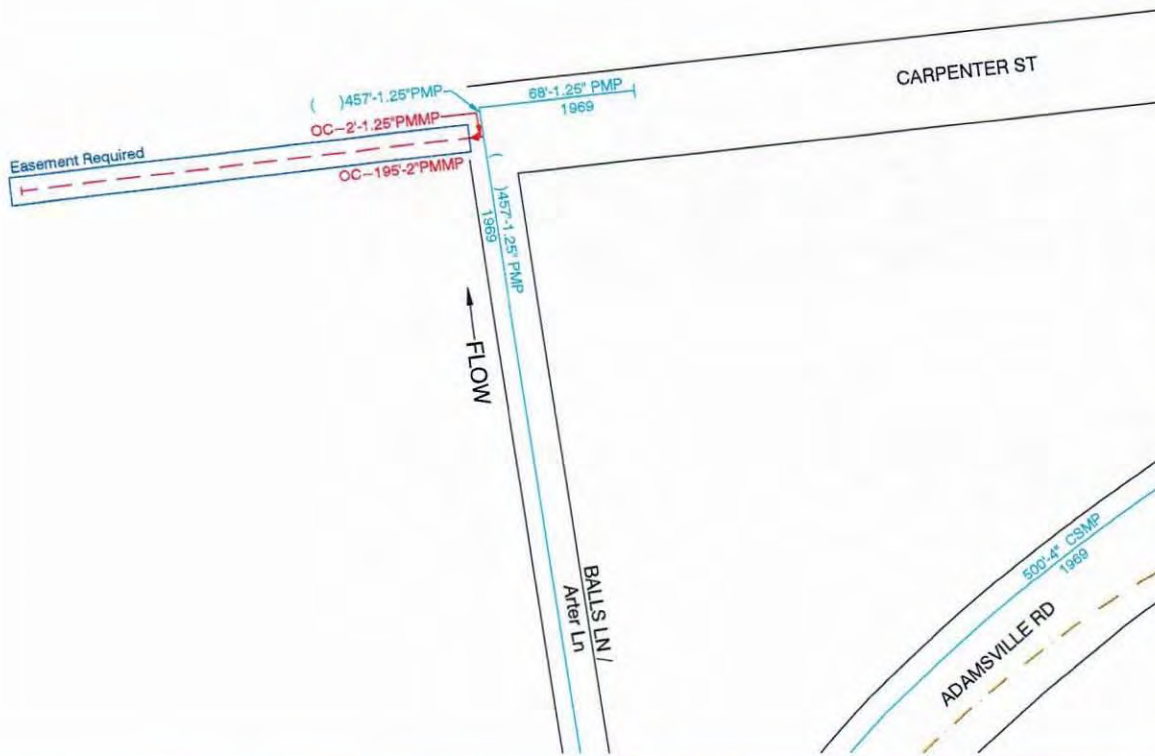

ORDINANCE 19- 25
INTRODUCED BY COUNCIL

AN ORDINANCE ALLOWING A MORAL CLAIM

WHEREAS, Ricky Hogan presented a legal claim in the amount of Two Thousand, Eight Hundred Forty-Six Dollars and Twenty-seven Cents (\$2,846.27) against the City of Zanesville; and,

WHEREAS, said claim was reviewed by the Law Director, David J. Tarbert and said claim was denied;

WHEREAS, the basis of said claim is set forth in Exhibit A; and,

WHEREAS, Law Director, David J. Tarbert, advised the claimant they had a right to present a moral claim to City Council; and

WHEREAS, City Council has reviewed the claim and determined that said claim should be paid as a moral claim in the requested reduced amount of Eight Hundred Thirty-Five Dollars and Ten Cents (\$835.10) as agreed by Ricky Hogan to cover the cost of his deductible and rental car during repairs.

NOW, THEREFORE, BE IT ORDAINED, by the Council of the City of Zanesville, Ohio, that:

SECTION ONE: The proper City Official is hereby authorized to pay \$835.10 to Ricky Hogan and said monies shall be taken from line item 202-6541-53408.

SECTION TWO: This Ordinance shall take effect and be in force from and after the earliest period allowed by law.

I was parked at my mother's house at 917 Marietta Street. I had stopped to borrow her chainsaw to cut up some trees that had fallen at my house in South Zanesville. When I started to back out of her driveway to leave, I noticed the Street sign laying in the grass; some 20-30 feet on the other side of my car, and probably 40-50 feet away from the utility pole (distances are estimates only). I called my mother outside, to show her the sign had blown off. At that time, I realized that the path the sign traveled to get in the yard, would have went towards my vehicle. I then turned around, and that is when I seen that it had hit my vehicle, and did a significant amount of damage. I took pictures of the damage to my car, and the sign laying next the pole in which it blew off of. When I spoke to the two firemen, they stated that they did see it blowing while on the utility pole, and then seen it blow off and hit my car. I did not call the police to report it, as I was not in an accident, and I did not feel at the time I would need a report. I did call my insurance company and start a claim. After speaking with my insurance agent, the recommended I call the city to see if they would be responsible for the damage, or to see that my options were. This incident happened between 12:30p – 1:15p. The images I took, are time stamped a little after 1pm Sunday 02/24/2019.
