ORDINANCE 19 - 26
INTRODUCED BY COUNCIL

AN ORDINANCE ALLOWING A MORAL CLAIM

WHEREAS, Michael R. Willett presented a legal claim in the amount of Two Hundred Eighty-Six Dollars and Sixty-five Cents (\$286.65) against the City of Zanesville; and,

WHEREAS, said claim was reviewed by the Law Director, David J. Tarbert and said claim was denied;


