**AN ORDINANCE AUTHORIZING THE MAYOR TO EXECUTE A LETTER OF ENGAGEMENT
WITH ABM BUILDING SOLUTIONS, LLC AS THE CITY OF ZANESVILLE'S PROVIDER OF
CHOICE FOR AN ENERGY SAVINGS INVESTMENT AUDIT**

WHEREAS, the City of Zanesville desires to have an Energy Conservation Report of its facilities and systems prepared in accordance with Ohio Revised Code Section 717.02(C); and

WHEREAS, the City of Zanesville developed and advertised (3/21/19) a Request for Qualifications (RFQ), and upon receipt staff determined ABM Building Solutions, LLC as the most qualified to perform such energy savings work; and

WHEREAS, upon conclusion and submission of the Energy conservation Report, City Council will consider authorizing a contract with ABM Building Solutions, LLC to implement energy conservation measures pursuant to Section 717.02 of the Ohio Revised Code.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Zanesville, State of Ohio, that:

SECTION ONE: The Mayor is hereby authorized to execute a Letter of Engagement with ABM Building Solutions, LLC, attached as "Exhibit A" for performing an Energy Conservation Report of the City of Zanesville's.

SECTION TWO: This Ordinance shall take effect and be in force from and after the earliest period allowed by law.
