## Second Right of Internment Agreement

This agreement is made between the City of Zanesville and the undersigned individual(s) ("the Customer") for the Second Right of Internment on an existing grave space.

### Purpose of this Agreement

Normally, each grave purchased includes only one burial right. Families wishing to place additional cremated remains in a full-sized plot may do so by purchasing a Second Right of Internment. This agreement outlines the terms and conditions under which this second (or additional) burial may occur.

### Terms & Conditions

By signing this agreement, the Customer acknowledges and agrees to the following:

1. **Ownership:**  
I understand that I am not purchasing land or property, but rather the **right of interment**. The land remains the property of the City of Zanesville.

2. **Compliance with Cemetery Rules and Regulations:**  
I agree to abide by all Cemetery rules and regulations, including but not limited to decoration guidelines and plot maintenance policies. I understand that these are detailed in the official Rules and Regulations document, and I accept any future updates made by Cemetery

management. Unauthorized decorations or alterations may be removed without notice.

3. **Monument and Marker Limitations:**

I understand that **only one monument/headstone is allowed per individual grave space**. No additional flat markers or ground-level plaques will be permitted to mark additional cremains. The only exception to this rule is for a Veteran-issued ground marker.

If additional burials are to be marked, I understand that this must be done by adding to or updating the existing headstone.

4. **Maximum Cremains:**

I understand that a maximum of six (6) additional cremated remains may be interred in a single full-sized grave.

- No additional cremains may be interred in cremation plots, Veteran sections, infant-sized plots/children's sections, or indigent plots.
- The City of Zanesville reserves the right to limit the number of cremains based on monument space, size and stability of the footer, existing grave layout, and any other unforeseen conditions that may prevent safe or respectful burial

5. **Second Right of Internment Fee:**

I acknowledge that a Second Right of Internment fee applies and must be paid in full before interment occurs.
